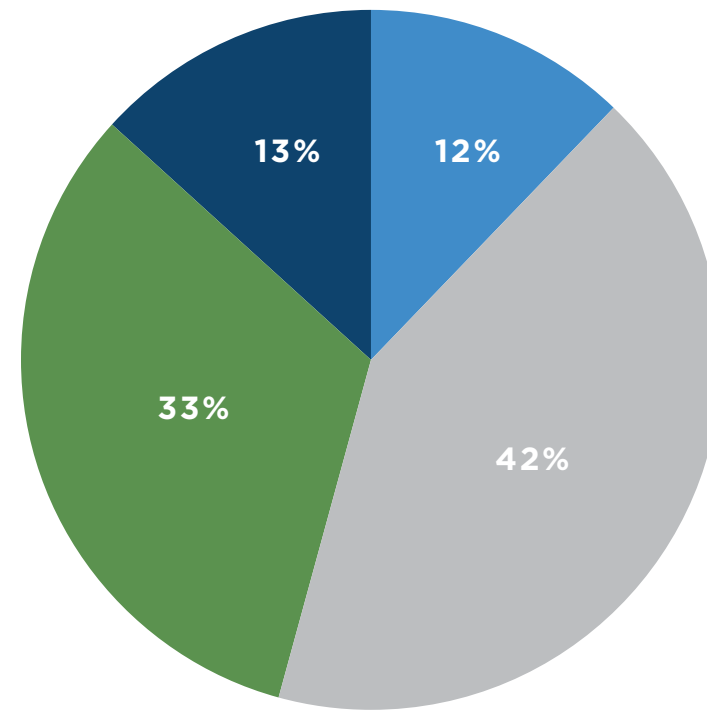


PRESERVATION

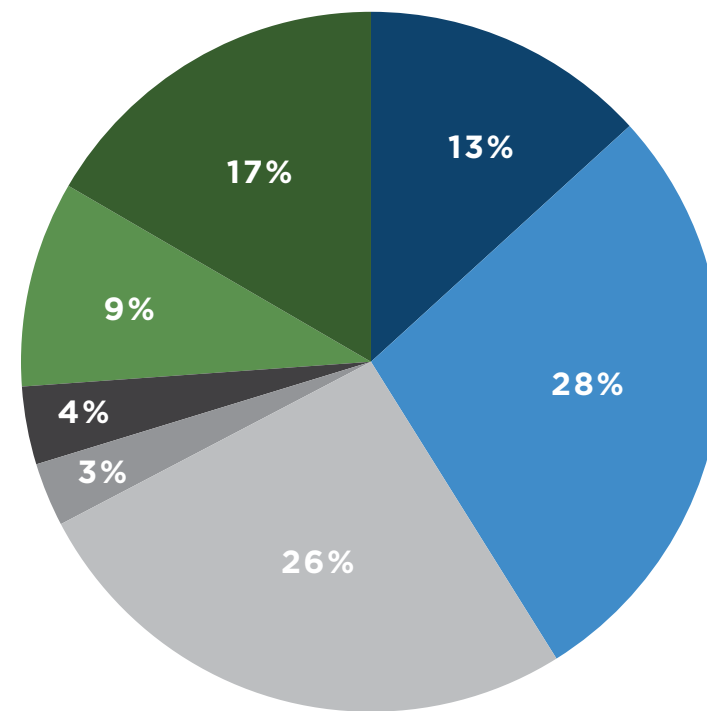
